For those who have never been to an ABWA conference - it's a must!







- Spotlight speaker Katherine Umland briefed attendees about her "Get To Know Bag" and "Pathways To Health"
- Anna Clark -Elect Nominating Chairperson Sandra Curtis and president's award announcement.
- The Feb.05, 2004 minutes were read and approved.
- Tatyana Shan briefed attendees about Local Scholarships
- Anna Clark briefed attendees on the Long Beach Spring Conference for March 19th-21st, 2004, Top Ten Nomination-Due to National Headquarters-May 15,2004 and Elections in May 2003.
- Stacy Moffat briefed attendees on the New Member Welcome Tea Meeting on Feb.22, 2004.
- 50/50 drawing winner was Sandra Curtis for \$25.
- Door prizes were given away.
- Spotlight speaker winner for April is Anna Clark
- 8:25 pm meeting adjourned.

PROPOSED STANDING RULES ABWA Soaring Eagles Chapter #6495

- 1. The monthly minutes of our Chapter Meeting and the monthly Treasurer's report will be published in the newsletter each month.
- 2. The Executive Board may approve expenditures of up to \$100.00 without the approval of the general membership.
- 3. The Chapter will accept Primary and Secondary members. Secondary members may not hold executive board positions or request reimbursement from the member education fund.
- 4. Attendees at the monthly Chapter meeting will pay the minimum dinner charge. (Added 7-17-03)
- 5. There will be a fee of up to \$25.00 to cover bank charges assessed for any returned check. After a second returned check, the member must pay in cash. (Amended 9-5-02)
- 6. If a member's National dues lapse, the remaining paid up dues shall be refunded and all member privileges revoked. (Added 7-17-03)
- 7. The Chapter will send the Chapter President to the National Convention. The Chapter will pay the President's <u>early</u> registration for ABWA National Convention. Transportation and one-half of the room rental for the delegate (not to exceed four nights) will be reimbursed, if the Chapter Treasury general funds so allows. In the event that the President is unable to attend, then priority will be given as follows: the Woman of the Year, Executive Board members, General Membership. (Amended 2-17-04)
- 8. (Moved to #7, 2-17-04) If proceeds are available from Member Education, the Chapter Top Ten Nominee may be reimbursed for the ABWA National Convention Woman of the Year luncheon cost.
- If proceeds are available from Member Education, the Chapter Woman of the Year may be reimbursed for up to \$500 for the ABWA National Convention <u>early</u> registration and the Woman of the Year luncheon cost (Amended 2-17-04)
- 10. If proceeds are available from the Scholarship fund, a yearly donation may be made to the SBMEF, up to \$1,000. (Amended 2-17-04)
- 11. Proceeds from the annual fundraiser are to be split 50/50 between the Scholarship fund and the Member Education fund. (Amended 7-17-03)
- 12. The Chapter Advisor shall be the immediate past president. If she is unable to serve the Chapter Advisor will be appointed by the outgoing Executive Board at the end of the term. The Chapter Advisor will not have a vote on the Executive Board.
- 13. A member of the Executive Board will serve on the Scholarship and Member Education Committees
- 14. Any member elected as Chapter Woman of the Year will not be eligible for selection until three terms have passed. (Added 1-02-03)
- 15. After a review of the Standing Rules by the Ad hoc committee, they will be published three times in the newsletter before going to vote by the general membership. (Amended 2-17-04)
